## **Covid-19 Safety Measures - TURF**

### **COVID-19 Precautions**

- Please stay home if you are ill, have symptoms of COVID-19, have been in contact with someone with known symptoms, or have been in contact with someone who has tested positive for COVID-19.

-Each group/league/association will be responsible for Covid-19 screening each of their participants including the parent/guardian prior to entering the facility. The self assessment can be found on the Health Unit's website <https://covid-19.ontario.ca/screening/worker/> .

-Groups/leagues/associations are responsible for submitting a contact tracing record of each participant as well as the parent/guardian. Information will include name, phone number, date, and time. This information must be clearly printed and accurate.

-Ensure you are maintaining a physical distance of six feet/two meters with anyone outside of your household or social circle.

### **Arriving at the Beckwith Recreation Complex**

-Turf users will enter the facility at the east door of the turf building and NOT the lobby. The Lobby will remain closed. The Turf facilities will remain locked and it will be the responsibility of each user group/league/association to monitor the door for 10 minutes prior to the turf time(s) to allow entry and to ensure everyone has exited no more than 5 minutes after their scheduled turf rental.

-The designated individual should arrive 15 minutes prior to the scheduled turf time to check in with staff.

-Players/coaches/parents should arrive no sooner than 10 minutes prior to the turf time, and no later than 5 minutes prior to the turf time.

Beginning Wednesday September 22<sup>nd</sup>, 2021, as per the COVID19 Provincial guidelines, all those under 18 playing a recreational sport do not have to provide proof of vaccinations when entering our recreational facilities. All those who are associated with the playing of the recreational sport i.e. Game and Team officials also do NOT have to show proof of vaccine

All spectators 12+ must show proof of vaccine or they will not be allowed entry to the recreational facility. It is the responsibility of the user groups to confirm all spectators have been fully vaccinated.

-When entering the facility, please use the hand sanitizer provided and wash your hands often. Face coverings must always be worn.

- Players must go directly to the allocated side of the turf building.

- No Spectators will be permitted.

- No food or drink is permitted.

## **During Your Stay at the Beckwith Recreation Complex**

- Please be aware of your surroundings and look for signage that has been posted.
- Persons engaged in physical sport may remove their face covering prior to stepping on the turf and must put their face covering back on while exiting the turf.
- Washrooms access is in the Turf Change rooms. Please note the Change rooms are closed and used for washrooms only. Participants are encouraged to arrive dressed.
- Prolonged or deliberate physical contact between players/coaches on the turf is not permitted.
- Users are not to share water bottles & all water bottles must have the participants name on it. Spitting will not be tolerated.
- The canteen will remain closed until further notice.

## **At the Completion of your Rental Time**

- Groups will be limited to no more than 5 minutes in the turf building after their scheduled turf rental and must exit the facility immediately.
- Once you leave the facility, you will not be permitted back in.

**If the contract holder does not comply with the regulations, it could result in lost turf time at the contract holders expense.**
