Updated Covid-19 Safety Measures

COVID-19 Precautions

- Please stay home if you are ill, have symptoms of COVID-19, have been in contact with someone with known symptoms, or have been in contact with someone who has tested positive for COVID-19.

-Each group/league/association will be responsible for Covid-19 screening each of their participants including the parent/guardian prior to entering the facility. The self assessment can be found on the Health Unit's website <https://covid-19.ontario.ca/screening/worker/>.

-Groups/leagues/associations are responsible for submitting a contact tracing record of each participant as well as the parent/guardian. Information will include name, phone number, date, and time. This information must be clearly printed and accurate.

-Ensure you are maintaining a physical distance of six feet/two meters with anyone outside of your household or social circle.

Arriving at the Beckwith Recreation Complex

-It will be the responsibility of each user group/league/association to monitor the door for 20 minutes prior to the ice time(s) to allow entry and to ensure everyone has exited no more than 20 minutes after leaving the ice surface.

- The designated individual should arrive 25 minutes prior to the scheduled ice time to check in with arena staff.

- The designated individual is responsible to actively screen all those that enter the facility during their booking.

- The designated individual is responsible to keep a contact tracing list of all those whom enter the facility during their booking and it must be provided to staff before their departure.

Beginning Wednesday September 22nd, 2021, as per the COVID19 Provincial guidelines, all those under 18 playing a recreational sport do not have to provide proof of vaccinations when entering our recreational facilities. All those who are associated with the playing of the recreational sport i.e. Game and Team officials also do NOT have to show proof of vaccine

All spectators 12+ must show proof of vaccine or they will not be allowed entry to the recreational facility. It is the responsibility of the user groups to confirm all spectators have been fully vaccinated.

-When entering the facility, please use the hand sanitizer provided and wash your hands often. Masks must always be worn, including in the dressing rooms. We ask coaches to also wear masks on ice as much as possible.

- Players / skaters must go directly to the allocated dressing room.

- Only ONE parent / guardian will be permitted in the facility with the child. Parents / guardians must go directly to the bleachers. It is the responsibility of the group / league / association to monitor one parent / guardian per child.

- Spectators must only sit with members of their own household, remain 6 ft / 2 meters from people outside of their household, wear a mask at all times and must leave immediately after the rental to allow for the next group to enter.
- No food or drink is permitted.

During Your Stay at the Beckwith Recreation Complex

-Please be aware of your surroundings and look for signage that has been posted.

-Persons engaged in physical sport may remove their face covering prior to stepping on the ice and must put their face covering back on after exiting the ice.

-Access to the dressing rooms will be permitted, however keys will not be given out. Each group will be limited to 20 minutes in the dressing room prior to their scheduled ice time and 20 minutes after they leave the ice. Participants are encouraged to arrive dressed, except for skates, gloves, and helmet.

-Ice times are only permitted two dressing rooms per hour of ice.

-Unless participants require help getting dressed, they must remain in the dressing room(s) until all participants from the previous hour are off the ice, in their allocated dressing room and the Zamboni has flooded the ice.

- Coaches will not be allocated a dressing room.
- Prolonged or deliberate physical contact between players/skaters on the ice is not permitted.
- Users are not to share water bottles & all water bottles must have the participants name on it. Spitting will not be tolerated.
- Time keepers must wear a mask.
- The canteen will remain closed until further notice.

At the Completion of your Rental Time

-Groups will be limited to no more than 20 minutes in the dressing room after they leave the ice surface and must exit the facility immediately.

-Showers are permitted, however only one person in the shower at a time and you must not exceed the 20 minute time limit.

- Waiting / conserving in the hallways/ common areas is not permitted, these areas must remain clear at all times.

If the contract holder does not comply with the regulations, it could result in lost ice time at the contract holders expense.
