**TAKE NOTICE** that the Planning Committee for the Corporation of the Township of Beckwith will consider an application to a Site-Specific exception to comprehensive Zoning By-Law No.91-14 and to enter into a Site Plan Control Agreement, being processed under **File Nos. ZA-07-23 and SP-12-23**, at the Planning Committee meeting scheduled for **Tuesday, September 19, 2023 at 7:00pm** in the Council Chambers at the Municipal Building, 1702 9<sup>th</sup> Line Beckwith.

**THE PURPOSE AND EFFECT** of the Site-Specific Zoning Amendment and Site Plan Application are to demolish the existing cottage and construct a new primary dwelling with reduced Side Lot Line Setback and High Water Mark Setback.

**EXPLANATORY NOTE:** Under the Township's Official Plan and Site Plan Control By-Law, all development within the Flood Plain zone is subject to Site Plan Control. Any redevelopment within the Flood Plain Zone also requires a Site-Specific Zoning Amendment.

**THE KEY MAP** on the reverse indicates the location of the lands affected by the proposed zoning amendment and site plan control in relation to other lands within the Municipality.

**ANY PERSON** may attend the Public Meeting and/or make written or verbal representation either in support of or in opposition to the proposed Zoning Amendment and Site Plan Control Approval. If you wish to be notified after a decision regarding the Zoning Amendment and Site Plan Control Approval have been made, you must make a written request to the Corporation of the Township of Beckwith.

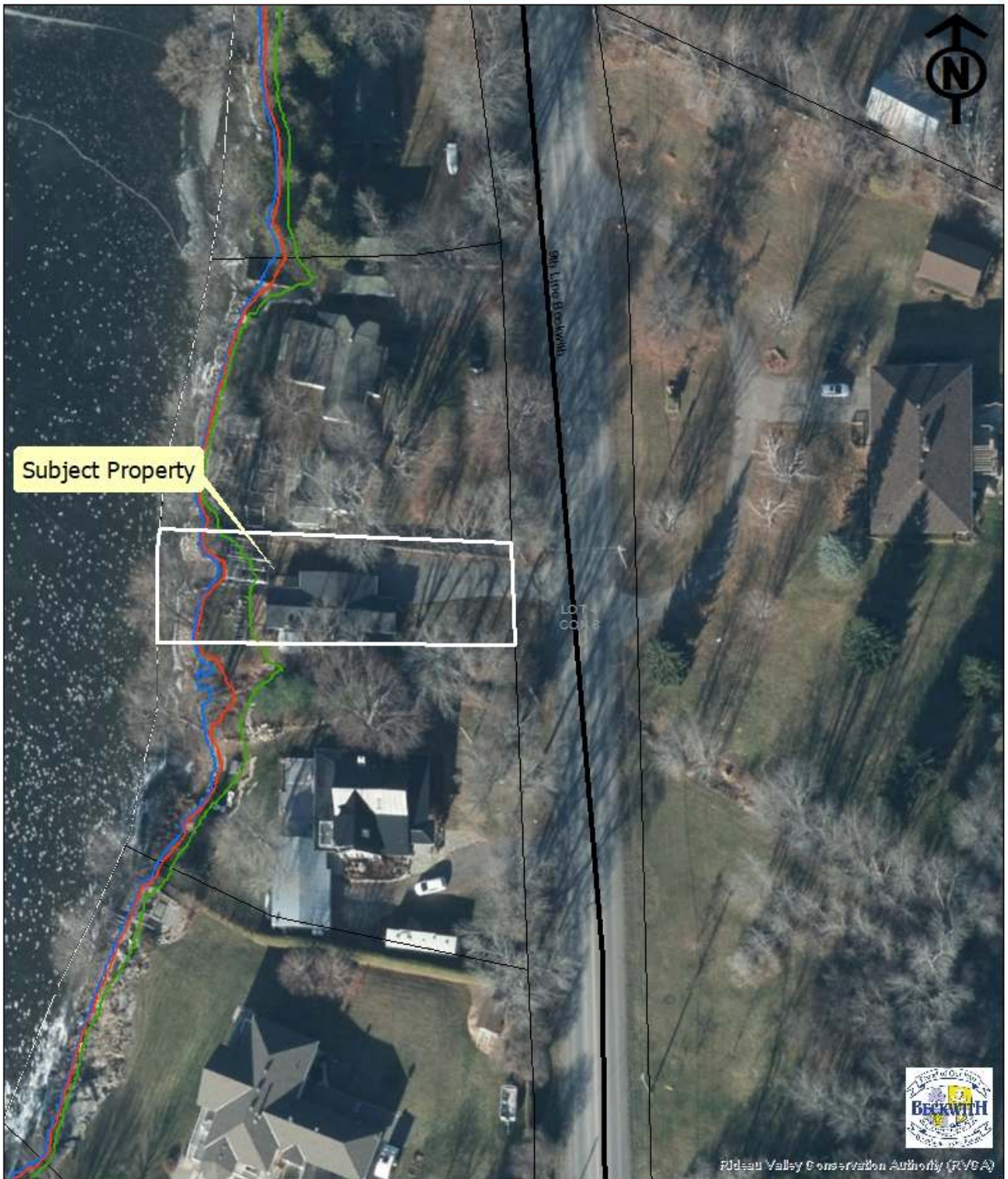
Only the owner of the property can file an appeal of a decision of the Corporation of the Township of Beckwith in respect of the proposed Site Plan Control Approval.
